Each of BCI and BCP disclaims beneficial ownership of such securities except to the extent of its pecuniary interest therein.

BCI is the managing general partner of each of BCIP Associates II ("BCIP II"), BCIP Associates II-B ("BCIP II-B"), BCIP Trust Associates II ("BCIPT II"), BCIP Trust Associates II-B ("BCIPT II-B"), BCIP Trust Associates II-B ("BCIPT II-B"), BCIP Trust Associates II-C ("BCIP II-C"), BCIP Repurchase Holdings ("BCIPTH") and BCIP Trust Repurchase Holdings (BCIPTRH" and, together with BCIP, BCIP II-B, BCIPT II-B,
- 4. BCI is the attorney-in-fact for PEP Investments PTY Ltd. ("PEP") and as a result, BCI may be deemed to share voting and dispositive power with respect to the shares of Common Stock held by PEP. BCI disclaims beneficial ownership of such securities except to the extent of its pecuniary interest therein.
- 5. Includes 984 shares sold by BCIPT II and 379 shares sold by BCIPT II-B. BCI disclaims beneficial ownership of all such shares in which it did not have a pecuniary interest.
